# Global Governance & Law Experience – Law School SUMMER 2024

#### 1. OBJECTIVE

Esade Law School wants to attract talented students and give opportunities to those who wish to study at Esade and have an outstanding academic record, but do not have sufficient financial resources. Therefore, the Esade Foundation is awarding Law Summer School Scholarships using its own funds and donations.

#### 2. GENERAL REQUIREMENTS

Candidates for this scholarship must:

- \* Be between 15 and 18 years of age.
- \* Provide evidence that their families would be unable to finance the cost of the program. Unless it is an exceptional situation, scholarships will not be granted when gross income for a family of four exceeds €60,000 per annum.
- \* Prove their academic ability by presenting their grades for the last two years.
- \* Submit the scholarship application before the deadline. All requested documentation must be provided for the application to be accepted.
- \* Attend a personal interview prior to the scholarship being awarded.

The generic nature of this Call for Applications is directed at those who meet the established legal requirements.

#### 3. REQUIRED DOCUMENTATION

- 1. The duly completed *scholarship application*.
- 2. The duly completed **Declaration of Family Assets** (attached) and a copy of the **wealth tax declaration**, if pertinent.
- 3. A copy of the **2023 and 2022 personal income tax declarations** of all family-unit members for **fist-year programme candidates**.
- 4. In addition to their personal income tax declarations, all contracted employees are required to present a **certificate of income** from their employers for the current year underway.
- 5. In case of separation or divorce, a signed copy of the corresponding **separation/divorce** agreement.

6. A copy of the *receipt of payment for the school/institute where candidates are completing their baccalaureate* and, if receiving a scholarship to study there, a *certification* of said scholarship issued by the granting institution.

To award scholarships as equitably as possible, the Talent Attraction Committee may use any and all the candidates' data which Fundació Esade has available. At the same time, it may gather any other data it deems necessary to evaluate the candidates' circumstances when both awarding the scholarship initially and to assess if those circumstances remain unchanged throughout the period encompassed by the scholarship.

#### 4. SCHOLARSHIP AMOUNT

The Scholarship will cover 50% of the corresponding tuition fees.
